PENSION-AD HOC INCREASE TO STATE GOVERNMENT PENSIONERS-ORDERS ISSUED.

ORDER

In the Government Proceeding read as first paper above, the rates of temporary increase in pension application to the pensioners of the Travancore- Cochin and Malabar areas of the state were unified with effect form 1-11-1957 as follows:-

Temporary increase per mensem

Pension u	up to Rs.5	per mensem

Pension of Rs.5 and above up to Rs.30 Pension of Rs.30 and above up to Rs.300 Temporary Increase equal to pension Subject to a minimum of Rs.4. Rs. 7-8-0 Rs.9-0-0 subject to the condition that pension plus temporary Increase should not exceed Rs.300 per mensem

In the G.O second, these rates of temporary increase were enhanced to Rs. 10 with effect from 1-4-1960 in the case of those who retired from service prior to 1-14-1960 and who were drawing a monthly pension not exceeding Rs.100 .It was also provided therein that no pensioner who retired from service prior to 1-4-1960 would get less than Rs.15 per mensem as pension inclusive of temporary increase. In the G.O third cited enhanced to Rs. 20 per mensem with effect from 1-4-1964.

- 2. Pensioners of the State Government have been representing for some time past, for enhancing in D.A in view of the rise in cost of living. The rates of D.A (temporary increase) admissible to the pensioners of the State compare favorably with the rates admissible under the Government of India and the Government of Madras. This Government has not sanctioned any relief to their pensioners recently. The State Government have recently increased the rates of D.A admissible to Government servants with effect from 1-10-1965 in view of the rise in cost of living. General revision of the scales of pay of State Government servants will also be given effect to from 1-1-1966.
- 3. In the circumstances Government consider that some relief should be given to the service Pensioners also, and are therefore pleased to order as follows:-

G.O. (p) 113/66/Fin

- (i) An ad hoc increase of Rs.5 per mensem will be granted to an service pensioners in the State drawing not more than Rs.300 per mensem as pension including temporary increase.
- (ii) In the case of pensioners drawing between Rs.300 and Rs.305 as pension there will be marginal adjustments so that the pensioners plus the ad hoc increase now sanctioned does not exceed Rs.305.
- (iii) This ad hoc increase will take effect from 1-1-1966 i.e on pensions for January 1966 due in February 1966.
- (iv) Wth the ad hoc increase now sanctioned the minimum pension plus temporary increase admissible to a service pensioner will be Rs. 25 per mensem.
- (v) Pension for this purpose shall onclude the commuted portion also, if any.
