PAY- FIXATION OF PAY IN THE REVISED SCALES OF APPOINTMENTS/PROMOTIONS MADE DURING 1-1-1966 TO 4-4-1966 – ORDERS ISSUED.

ORDER

Orders were issued on April 5, 1966 in G.O. (P) 112/66/Fin. revising the scales of pay of Government employees with effect from January 1, 1966. According to the orders in paragraph 1 (vi) of the G.O. read as third paper above, appointments and promotions made in the intervening period from 1-1-1966 to 4-4-1966 should be deemed to have been made to the revised scales of pay of the posts concerned. As a result of these orders pay in the revised Scale in certain cases of appointments/promotions made in the above intervening period is less than the pay admissible in the pre-revision scales of the posts. Protection against such drop in emoluments was afforded in the 1958 revision in G.O.MS. 233/58/Fin. dated 19-8-1958. A similar protection has been given in the present revision in the G.O. second cited to graduates appointed as Lower Division Clerks in the pre-revision scale of Rs. 40-120 during the period 1-1-1966 to 4-4-1966. In the circumstances Government are pleased to issue the following orders in partial modification of the Orders in the G.O. read as third paper above.

In the case of appointments or promotions made during the period from 1-1-1966 to 4-4-1966 the pay of the Officer in the revised scale will be fixed at such amount as he would have drawn as pay and dearness pay but for the revision if that represents a stage in the revised scale and if not at the stage next below such amount the difference being treated as compensatory allowance to be absorbed in future increases in pay. Special pay, if any, admissible in the pre-revision scale will also be reckoned for fixation of pay in the revised scale as indicated in Note (ii) to rule 2 in Annexure II to the G.O. read as first paper above.

In the case of re-appointments or re-promotions pay will be regulated as ordered in para 1 (i) of G.O.(P) 379/66/Fin. dated 17-8-1966.
