By the notification read the Government of India have amended the form of medical certificate in the civil Pensions (Commutation ) Rules , As the form of the medical certificate prescribed in part 111 of Form Cin Appendix x , Kerala Service Rules is the same as the one prescribed by the Government of India in the above rules and as the amended the form on the lines modified by the Government of India , Accordingly the following notification is issued , .

**AMENDMENT**

In the said Rules, in Appendix x, for Part 111 of Form C, THE FOLLOWING SHALL BE SUBSTITUTED,

**OR**

He/ She are not in good bodily healthy and are not a fir subject for commutation. Although he / she is suffering from ..... he / she is coincided a fit subject for communication but his / her age for the purpose of commutation ie , the age next birth day should be taken to be ..... (In words) years more than his / her actual age.
