In the Government Orders read above, necessary funds were apportioned to various District Collectors & Principal Census Officers of each District for meeting the expenditure in connection with the Census Operations.

In view of convenience, the Government decided to disburse the amount to the Forest Charge officials centrally and directly through the Chief Conservator of Forests and the was asked to quantify the amount required for effecting payment of honorarium and other allowances to the various Census Functionaries posted in the Forest Charges.

Taking cue from the proposal of the Chief Conservator of Forest, Government are pleased to sanction Rs.27,60,000/- (Rupees twenty seven lakh sixty thousand only) from the head of account "8449-120-85-Deposit for payment of honorarium to Enumerators and salary to the staff in connection with 2011 Census".

The Chief Conservator of Forest will apportion the amount to the respective Charge Officers as per their requirement who in turn will draw the amount from the respective Treasuries. The Director of Treasuries and the District Treasury officers concerned will instruct the subordinate treasury officers to entertain the bills submitted by the Charge Officers.

The Chief Conservator of Forests shall furnish to Government a consolidated statement of accounts relating to the expenditure incurred by the Forest Charge officers duly reconciled.
