- Sub:- Pension –Expeditious disposal of pension cases-Monthly statement showing the progress of action in disposal of pension cases-Conversion into quarterly statements –Instructions issued.
- Ref:- 1. Circular No 48/71/Fin, dated 12-6-1971.
 - 2. Circular No 91/77/FIN,dated 13-9-1977.

In the circulars cited instructions were issued that all pension sanctioning authorities should furnish to Government monthly statement showing the progress of action taken on pending pension cases and the details of action taken in respect of retirements due to taken lace within one year from the last day of the month to which the statement of pensionary claims. Now due to liberalization on pension rules and the timely action taken by the pension sanctioning authorities in the settlement of pension cases, the pendency of pension cases has considerably been reduced. It has therefore, been decoded not insist on the monthly statements of pending cases from the pension sanctioning authorities. All pension cases from the pension sanctioning authorities are therefore informed that hereafter only quarterly statement need to be furnished to Government in the form appended to this circular beginning from the second quarter of 1978 ending 30-6-78. The statement should be forwarded to Government before the 10th of the month following each quarter.
