#### **NOTIFICATION**

S.R.O.NO.179/78- In exercise of the powers conferred by sub-section(1) of section 2 of the Kerala Public Service Act,1968(19 of 1968) ,read with section 3 there of ,the Government of Kerala makes here by the following amendment to the Kerala Service rules ,namely:-

# AMENDMENT C.S.No.337/78.

In part III of the said rules, after rule 110, the following Notes shall be inserted namely:-

"Note:- The authority competent to make appointment to the vacated by the retiring Government Servant shall be compete to sanction the pension of that retiring Government Servant. However, the Government shall have also power to sanction the pension of any retiring Government Servant".

# **Explanatory Note**

The revised edition of Kerala Service Rules part III Volume II (1974) does not specify the authorities competent to sanction pension. The examiner of local Fund Accounts in his letter cited has requested clarification as to sanctioning pension. Considering the necessity to have a clear provision on this, Government, in consul consultation with the accountant, have decided to issue the above notification.
