ORDER

In the G.O read as third paper above, Government have issued orders regarding the procedure to be followed for the disbursement of the amount due to the legal heirs of the Family Benefit Scheme who die while in service. But no orders have been issued as to how the disbursement of the amount due to the subscribers of the scheme who quit service on retirement/ relief is to be made. Government is pleased to issue the following orders in the matter:-

In cases where the subscribers leave service on retirement/ relief, the amount due to them under the family benefit scheme will be disbursed by the Head of Office, if the latter is a Gazetted Officer. Where however the Head of office is a non-gazetted officer, details of the amount due for disbursement to the subscriber will be worked out by him and communicated to the Gazetted officer having immediate control over him with all the connected papers, recording his recommendation for payment. The latter, after making such enquiries as he may deem necessary, will draw and disburse the amount. The drawing and disbursing officers will follow the procedure laid down in paras (iv) and (v) of the G.O.read as third paper above for the withdrawal of the amount and maintenance of the records of closed cases.

The procedure details above will be followed for closing the accounts of the subscribers who go abroad on leave without allowances to take up employment in pursuance of the Government order read as second paper above.
