ORDER

In G.O.(p) 141/76/Fin. Dated 18-5-1976 orders were issued granting temporary increase in pension at the rate of Rs.15, Rs 13 and Rs ,10 per mensem to the three categories of pensioners who retire prior or 1-7-1973 and whose basic pension ranged between Rs.100 and Rs 200 p.m.In the same another increase of Rs.5 p.m. was allowed to all service pensioners whose basic pension did not exceed Rs.200 p.m.Marginal adjustments were also ordered separately for the two increases sanctioned in the G.O. read above. It has been represented to Government that this resulted in an anomaly as indicated below.

While a pensioner who retired prior to 14-11-1966 and whose basic pension is Rs 200 p.m. was eligible to get a total temporary increase of Rs. (15+5) another pensioner who also retired prior to 14-11-1966 and whose basic pension is Rs .205 would get the bebefit of an increas4e of Rs 10 only. Thus where the total pension including the temporary increase sanctioned in the G.O. in respect of the pensioner is Rs 220 theletterwill getonly Rs 215.Further marginal adjustments have therefore to be made to remove the above anomaly.

In the circumstances, the Government are pleased to issue the following further orders.

(i) The Temporary increase and increase sanctioned in G.O.(P) 141/76/Fin.dated 18-5-1976 will be taken while fixing the benefit of marginal increase.

(ii) In the case of those who retired prior to 14-11-1966 and drawing basic pension between Rs 200 and Rs 220 P,M,basic ension plus margial increase will be limited to Rs 220 PM.

(iii) In the case of those who retired during the period from 14-11-1966. to 31-3-1969 and drawing basic pension between Rs 200 and 218 P.M. basic pension plus marginal increase will be limited to 218 P.M.

(iv) In the case of those who retired during the period from 1-4-1969 to 30-6-1973 and drawing basic pension between Rs 200 and Rs 215 P.M. basic pension plus marginal increase will be limited to Rs 215 p.m.
