## Sub:-Additional Emoluments (Compulsory Deposit) Act, 1974-Premature Repayment of compulsory deposits on grounds of extreme hardship.

Sir,

In terms of the instructions contained in this Ministry's letter No.F9(4)-CD/78(1) dated the 3<sup>rd</sup> February, 1978, the State Governments are required to sent to this Ministry a consolidated quarterly report showing the particulars of premature repayments sanctioned to their employees. The last date for submission of this report is the end of the month following the quarter to which the report relates.

2. It has been noticed that the above reports are not being received regularly nor or the following prescribed instructions observed in compiling the reports.

- (a) The report should show the consolidated position in respect of all the Employees of the State Governments.
- (b) The figures of premature repayment ant interest payments should be Cumulative i.e. upto the end of quarter and not merely during the Quarter under report.
- (c) Premature repayments sanctioned due to hardship caused by cyclone, Floods and other natural calamities should be shown separately and for those sanctioned on other grounds (eg.medical), In other words, the report is to be split in two parts-one relating to natural calamities and other on medical grounds
- 3. From the quarter ended June, 1979, the report should be submitted in the enclosed proforma. The monthly report prescribed vide this Ministry,s letter No.F1.(12)-CD/78 dated the 27<sup>th</sup> November, 1978 may please be discontinued forthwith.
