**S R O No no.969/79**..In exercise of the powers conferred buy subsection (1) of section 2 of the Kerala Public 1968(19 of 1968)Service act, read with section 3 there of the Government of Kerala here by make the following amendment to the Kerala service4 Rules, namely:-

**AMENDMENT**

*(C.S. No. 361/79)*

1. (1) These Rules may be called the Kerala Service (Amendment) rules, 1979.
- (2) They shall come into force at once.

2. In part III of the Kerala Service rule in rule 102, in clause (1) of sub-rule (a) for items (a) (b) and(c) under the heading "Rate of military pension" and the entries them under the heading "Amount of reduction in civil pay", the following shall be substituted namely:-
