**ORDER**

Pursuant to the orders contained G.O and circular read above, Government are pleased to issue the following notification.

**NOTIFICATION**

**S.R.O No. 1289/79**-In exercise of the powers conferred by sub section (1) of section 2 of the kerala public Service Act, 1968 (19 of 1968). Sead with section 3 there of, the Government of kerala hereby makes the following amendment to the Kerala Service rules namely:-

**AMENDMENTS**

***C.S.O..365/79***

1. (i) There rules may be called the Kerala service (Amendment) Rules, 1979.

(ii) They shall be deemed to have some in to force with effect on and from the 22<sup>nd</sup> Day of May, 1970.

2. In part of the Kerala Service Rules, in clause (e) of rule 60 for the first and second paragraphs the following shall be substituted namely:

“The teaching staff of all educational institutions (including Principals of College) who complete the age of 55 years during the course of and academic year shall continue in service till the last day of the months in which the academic year ends. They shall be entitled to the benefit of increment if it falls due before the actual date on which they attain the age of 55 years. But they shall not be eligible for promotion to another post during the period of such extension. If they are on leave on the day they attain the age of 55 years and if there is no prospect of their returning to duty before the closing day of the academic year for vacation they shall be retired with effect from the last day of there months in which they attain the age of 55 years. But in case where officers coming under

this rule are under suspension on the date of superannuation or there after but before the closing day of the academic year they shall be retired form service on the date of superannuation or on the date of suspension whichever is later.

If however, the day on which the teaching stave (including principals oof Colleges) attain the age of 55 year falls within the period of one month beginning with the day of re-opening of the institution they shall cease to be on duty with effect be from the date of such re –opening and they shall be granted additional leave from the date of re- opening to the last day of the month in which they attain the age of 5 years. They shall be entitled to the benefit of increment if it falls due before the actual date on which they attain the age of 55 years”.

### **Explanatory Note**

The teaching staff of all educational institution 9 including principals of Colleges)who complete the age of 55 years during the course of an academic year shall be in service till the last date of the months in which the academic year ands under rule 60 ( c), K.S.R subject to the conditions stated therein .But such continuance beyond the date of superannuation would not confer on them any which is not available to other Government servants, except the salary for the extended period of service. The teaching staff was not thus eligible to draw increments during the extended period of service. Considering the hardship caused to the above category of Government servants, Government have decided to modify the provision suitably so that the teaching staff allowed to continue in service beyond the date of superannuation under rule 60 ©, part I.K.S.R could be granted increment during the extended period of service if it falls due before the actual date of superannuation . The above notification is intended to achieve this is object and also to give statutory validity to the contained in G.O. (P) 354/70/Fin. dated 22-5-1970.
