ORDER

It has come to the notice of Government that certain newly developed airports in the country are levying User Development Fee on the passengers alongwith the airfare or separately. Certain officers who have already paid it, have requested to re-imburse the same. As there is no provision in Part II Kerala Service Rules for the reimbursement of User Development Fee, Accountant General has objected to such claims by the Govt. officers.

Government have examined the matter in detail and are pleased to order that the officers who performed airtravel as part of official duties and transfer can claim User Development Fee alongwith their TA claims subject to the production of receipt from the concerned airport authority, if it is not charged alongwith airfare.

This order will have effect from the date of issuance.

Formal orders, incorporating the provision in Part II Kerala Service Rules will be issued separately.
