ORDER

Based on the decision of the Government of India to dispense with the renewal of P.P. O THE Director of Treasuries in his letter read as first paper above has suggested to replace the system renewal Of P.P.O by adding continuation sheets to the P.P.O whenever the disbursers and pensioners halves are fully used up.

The Accountant General, when consulted has agreed to the procedure suggested by the Director of Treasuries subject to the following condition –

1. The fact of adding additional sheets should be noted in the front page of the P.P. O specifying the number of cages available in the additional sheets and should be reported to the Accountant General.
2. The additional sheets issued should bear the full signature of the Treasury officer .
3. The renewal should be insisted on after 12 years ie, when the cages in the pensioners half / disbursers half are fully used up.
4. Spare copies of the additional sheets should be kept under the personal custody of the Treasury Officer himself.

2. Government have considered the question and are pleased to accept the proposal of the Director of Treasuries to replace the system of renewal of p.p. os by adding continuation sheets to the pension payment orders according to the conditions specified above

3. The Director of Treasuries will make necessary arrangement s in this regard . He will also arrange to print adequate No of additional sheets Spare copies of the additional sheets be kept under personal custody of the Treasury officer himself . Necessary precautionary measures to avoid manipulation will also be taken .
