ORDER

In the G.O. read as first paper above, Government have issued orders allowing the benefit of higher grade to all the categories of employees borne on the first nine scales of pay on completion of 13 years of qualifying service in that grade, irrespective or whether the grade is the entry grade or not. The benefit of the orders contained in the said G.O had been extended to all Non-Gazetted Officers including those in the scale of pay of Rs.600-1100 as per the G.O.second cited. Both these G.Os.Have effect from1-7-1979 with monitory benefit from 1-7-1980 only.

- 2. Certain Heads of Departments have sought clarification whether persons who become eligible for higher grade based on the G.Os. read above from 1-7-1979 and retired before 1-7-1980 are eligible for pensionary benefits on the basis of the notional fixation allowed from 1-7-1979 in the scale of pay of the higher grade.
- 3. Government have considered the proposal in detail and are pleased to clarify that employee who become eligible for higher grade based on the G.O.s read as first and second papers above with effect from 1-7-1979, with monetary benefit from 1-7-1980 and who retired before 1-7-1980, will be eligible for pension on the basis of average emoluments on account of notional fixation, but not gratuity which is admissible only on the basis of the actual pay drawn- Vide note 4 to Rule 63, Part III K.S.Rs.
 - 4. These orders will have effect from 1-7-1979.
