**S.R.O No.795/82.**- In exercise of the powers conferred by sub-section (i) of section 2 of the Kerala Public Services Act, 1968 (19 of.....) read with section 3 there of , the Government of Kerala here by......the following rules further to amend the Kerala Service Rules, namely:-

#### RULES

## C.S.No.411/82

- 1. Short title and Comment.-(i) These rules may be called the Kerala Service (Amendment) Rules ,1982.
- (ii)They shall be deemed to have come into force with  $\,$  effect from the  $31^{\rm st}$  March 1982.
- 2. Amendement of the Rules –In para 1 of the Kerala Service Rules, before the explanations to sub rule (c) of rule 60, the following exception shall be inserted, namely

"Exception: Extension of Service for one year will be given to winners of National and State Awards for teacher, conferred by Central and State Governments subject to the conditions that,

- (i) they are found physically and mentally fit,
- (ii) this benefits will be available only at the grade as which the award was secured,
- (iii) such persons, if they become eligible for promotion before the normal date of retirement will have to forgo such promotion to enjoy this benefit and
- (iv) this extension will be in continuation of the extension mentioned in this rule and on the same terms and conditions but the benefit of the additional leave will be granted at the time of the second extension.

## **Explanatory Note**

The teaching staff of all Educational Institutions (including Principals of Colleges) who complete the age of 55 years during the course of an academic year shall be in service till the last date of the month in which the academic year ends under Rule 60 (c) Part I KSR. By the G.O read as third paper above, Government have ordered that the age of retirement will be extended by one year in the case of winners of National and State Awards for Teachers conferred by Central and State Government subject to the conditions stipulated there in. This amendment is issued to give statutory validity so the above orders.
