S.R.O. No. 337/82- In exercise of the powers conferred by subsection (1) of section 2 of the Kerala Public Services Act, 1968 (19 of 1968) read with section 3 thereof, the Government of Kerala hereby make the following rules further to amend the General Provident Fund (Kerala) Rules, namely:-

Rules

- 1. (1) These rules may be called the General Provident Fund (Kerala) Amendment Rules, 1982.
 - (2) They shall come into force at once.
 - 2. In the General Provident Fund (Kerala) Rules,-
 - (1) rule 13 shall be renumbered as sub-rule (1), of that rule and after sub-rule (1) as so renumbered, the following sub-rule shall be inserted, namely:-
- "(2) In the case of a subscriber on deputation to a body corporate owned or controlled by Government, the subscription shall be recovered and forwarded to the Accounts Officer by such body."
- (2) After the second proviso to sub-rule (3) of rule 15, the following proviso shall be inserted, namely:-

"Provided also that in the case of amounts forwarded by the body corporate under sub-rule (2) of rule 13, the date of deposit shall be deemed to be the 1st day of the month, if it is received by the Accounts Officer before the 15th day of that month."

Explanatory Note

(This is not part of the Notification, but is intended to indicate its general purport).

In the case of deputationists within the state, to body corporates owned or controlled by Government, there is no specific provision as to whether who should forward to the Accounts Officer, the recoveries towards General Provident Fund effected from the pay of the deputationists. In such cases, however, the foreign employers are making remittances. If they fail to remit the amount deducted from the pay of the subscribers before the 5th of a month, interest is not allowed for the month. But in the Central Provident Fund Rules, there is a clear provision that in the case of a subscriber on deputation to a body corporate, owned or controlled by Government, the subscription shall be recovered and forwarded to the Accounts Officer by such body. The Central Rules also stipulate that in the case of amounts forwarded by the body corporates, the date of deposit shall be deemed to be the 1st day of the month; if it is received by the Accounts Officer, before the 15th day of that month.
