GENERAL PROVIDENT FUND (KERALA) RULES- PAYMENT OF MINOR'S SHARE OF PROVIDENT FUND MONEY WITHOUT PRODUCTION OF GUARDIANSHIP CERTIFICATE- MAXIMUM LIMIT ENHANCED – ORDERS ISSUED

ORDER

According to Note 2(b) under Rule 32 of General Provident Fund (Kerala) Rules, payment of minor's share of Provident Fund money to the extent of Rs. 5000 (or the first Rs. 5000 where the amount payable exceeds Rs. 5000) may be made without requiring the production of a guardianship certificate from the court to the natural guardian of the minor. The Accountant General in his letter read above has reported that in many cases where the minor's share of provident Fund money exceeded Rs. 5000, the claimants have not produced guardianship certificate from the court, possibly due to the reason that the amount in excess of Rs. 5000 was not considerable enough to get the certificate from the court. Since the limit of Rs. 5000 for payment of minor's share without production of guardianship certificate was laid down long back, the Accountant General has suggested enhancing the monetary limit.

Government have examined the matter in detail and are pleased to order that minor's share of Provident Fund money to the extent of Rs. 10,000 (or the first Rs. 10,000 where the amount payable exceeds Rs. 10,000) may be made without the production of a guardianship certificate from the court to the natural guardian of the minor.

Necessary amendments will be made in the General Provident Fund (Kerala) Rules accordingly.
