GROUP INSURANCE SCHEME FOR GOVERNMENT EMPLOYEES-EXTENSION OF TIME TO JOIN THE SCHEME GRANTED-ORDERS ISSUED

ORDER

In the G.O. read as first paper above, Government have introduced the Group Insurance Scheme for the benefit of the State Government Employees. The scheme was implemented with effect from 1-9-1984 and all employees who were in service as on 1-9-1984 were permitted to join the scheme. The time limit for joining the Group Insurance Scheme was extended by government till the end of April, 1985 as per the orders read as second, third and fourth papers above.

It was again been brought to the notice of the Government that a number of employees including those in educational institutions in the Public and Private Sector are desirous to join the scheme immediately. With a view to extend the benefit of the scheme to more number of employees Government are pleased to order that all employees in service could join the scheme till the end of 30-9-1985.

Government also wish to make it clear that no further extension of time will be granted to those employees who were in service on 1-9-1984 to join the scheme there after. The employees who are not covered by the scheme so far should be enrolled as full members of the scheme before 30-9-1985. Full subscription should be collected from these members at the rate of Rs.50, Rs.40, Rs.30 etc., per month from the month in which they are enrolled as members of the scheme.

The employees who have entered Government service during the period from 1-9-1984 to 30-9-1985 should also be enrolled as full members of the scheme during the extended period. They should be admitted to the scheme from the month they join Government service and subscription from them should be collected at the rate Rs.10, Rs.20, Rs.30 etc., depending on the group to which they belong.

Those employees who enter Government Service after 30-9-1985 should be admitted to the scheme, extending them the benefit of the insurance cover only as explained in para 6(i) of the G.O. read as first paper above. The monthly subscription in their cases would be Rs.3, Rs.6, Rs.9 etc. Such employees should be made full members on the next anniversary of the scheme (ie.on 1-9-1986).

All Heads of Departments and Offices are hereby directed to bring the contents of these orders to all the employees working in their respective departments/Offices and to enroll the maximum number of employees to the Group Insurance Scheme before 30-9-1985.
