**ORDER**

As per Note 2 to Rule 3 part III Kerala Service Rules, liabilities fixed against an employee can be recovered from the death-cum-retirement gratuity payable to him without any departmental or judicial proceedings as referred to in rule 3 but after giving the employee concerned a reasonable opportunity to explain. As the above note is applicable only in the case of employees and not in the case of pensioners it has been decided to bring the pensioners also under the purview of the above note. Consequent on the above decision the rulings No.1 and 3 below the rule also requires modification.

2. After detailed examination Government are pleased to order that after the word, employee the words "or pensioner" shall be inserted wherever the word employee occurs in Ruling No 1 and 3 below Rule 3, Part III Kerala Service Rules.
