PUBLIC SERVICE- VERIFICATION OF CHARACTER AND ANTECEDENTS OF GANDIDATES SELEECTED FOR APPOINTMENT IN PUBLIC SERVICE-INSRUCTIONS- AMENDMENT ISSUED

ORDER

In the G.O. read as first paper Government had laid down the procedure for verification of character and antecedents of candidates selected for appointment to Public Service. According to the above procedure no verification of character antecedents is necessary for the candidates selected for appointment to contingent establishments. How ever, the candidates selected for appointment to produce two certificate of character and conduct (In Form II) given by the certificates are obtained before the candidates are actually appointed.

- 2. In the G.O. read as second paper above Government had amended the above procedure and ordered that the character and antecedents before promotion of contingent employees to posts in regular establishment.
- 3. Representations have been received requesting Government to dispense with this practice of verification of character and antecedents before promotion of contingent employees to posts in regular establishments.
- 4. According to rule 3 of the Special Rules for the Kerala Last Grade Services, rule 10 (b) (iii) of the General Rules which provide for verification of character and antecedents of a candidates before his appointment in public service, will not apply to the Last Grade Services.
- 5. under the circumstances Government consider that no verification of character and antecedents is necessary for candidates selected for appointment to Last Grade Services and for promotion of contingent employees to posts in the regular establishment. The relevant item in the procedure for verification on character and antecedents selected for appointment to Public Services is therefore amended as follows:-

Item III relating to candidates recruited to Contingent Establish and para II thereunder still be

III Candidates recruited to contingent and Last Grade Establishments.

(II) No verification of and antecedents of candidate selected for appointment to Contingent and Last Grade Service is necessary. However the candidates selected for appointment shall be asked to produced two certificates and character in form if given by the Competent Officers. The Appointing Authority shall ensure that the certificates are obtained before the certificates are actually appointed.
