## **ORDER**

In the G.O read above, government have laid down among other \*\*\*\*\* the procedure to be followed and the principles can be adopted the matter of granting promotion to stenographers of the Secretariat \*\*\*\*\* Upper Division Clerks. It has since been pointed out on behalf of The /stenographer of the Secretariat that the orders in the above G.O do not afford any relief to the existing Stenographers and that so far as they are concerned the G.O will merely mean that instead of retiring as stenographers they will retire as upper division clerks, carrying almost identical scale of pay.

- 2. The government have reviewed the matter in detail in consultation with the Public service commission and are pleased to order as follows:-
- (i) for every eight vacancies of Superintendents in the Secretariat one vacancy will be reserved and filled up by promotion of qualified stenographers of the Secretariat with Account test (lower) qualification,. The promotion will be made on the basis of a test in drafting and precise writing to be conducted by the Public Service commission, subject to the condition that a stenographer will not be promoted in preference to a clerk who has the next chance of promotion as Superintendent and whose total length of service as lower division and upper division clerk is equal to or greater than of the stenographer.
- (ii) Graduate stenographers of the Secretariat who have passed the common test conducted by the erstwhile Travancore Public Service Commission will, however, he exempted from passing the proposed test. The following four stenographers are accordingly granted exemption from the test.
  - 1. Sri. R. Gopinathan.
  - 2. Sri. P.N. Balakrishnan Nair.
  - 3 Sri. K. Chandrasekharan.
  - 4. Sri.V. Gopala pillai.

The exemption granted to the above person will, however, come into operation only from the date of publication of the results of the proposed test to be conducted by the Public Service commission.

(iii) Orders in paragraph 2 (ii) of the G.O read above are hereby superseded by this G.O.
