## **Abstract**

MILITARY-GOVERNMENT SERVANTS-PERMITTED TO JOIN THE PROVINCIAL UNITSOF THE TERRITORIAL ARMY-PAY AND ALLOWANCES DURING THE PERIOD OF TRAINING-REVISED ORDERS ISSUED

## **ORDER**

In the G.O. read as the second paper above, permission was granted to Government servants to enroll themselves, in the provincial units of the Territorial Army and it was also ordered in that G.O. that during the period of training they would be allowed to draw both military pay and allowances and their civil emoluments. The Central Government was not permitting their secants to join the provincial units as the time when the above orders were issued. The Government of India, Ministry of Home affairs in their letter No. F-47/2/61- Ests(A) dated 7-6-1961 have now permitted their employees to join the provincial units of the Territorial Army on condition that while on training with the provincial units the period of absence from Government Office will be treated as duty and that they will be entitled to military pay and allowances, plus the difference between civil and military pay and allowances, if any, which will be a charge against the ordinary head of expenditure to which the civil pay of the government servant is debit able.

- 2. The Government considers that the procedure adopted by the Government of India in the matter may be followed in this State also. They, therefore, order in super session of the orders contained in paragraph 5 of the G.O. Ms. 373/Pub., dated 20-5-60 that the period spent by State Government Servants while on training with the provincial units of the territorial army will be treated as duty and that during such periods of training they will be entitled to military pay and allowances plus difference, if any, between Civil and Military pay and allowances and that the difference between civil pay and allowances and military pay and allowances shall constitute a charge against the ordinary head of expenditure to which the civil pay of the individual concerned is debatable, as laid down in paragraphs 5 and 6 of G.O. H7-611/51/CS ed 23-3-1951.
