## ORDER

In the G.O read as first paper above, the Post-graduate Diploma in rural Economics and co-operation awarded by the National council for rural Higher education was recognized by the State government for a period of 2 years from 15-6-1963 as equivalent to M.A.Degree of a recognized University for purposes of appointment to posts under Government for which MA degree (without specifying subjects) of a recognized university is the prescribed qualification. Subsequently in the G.O's read as second and third paper above, third recognition was extended up to 14-6-1969. the government of India in their letter read as fourth paper above, have extended the recognition granted to the Post- Graduate Diploma in question, for a further period of two years i.e. up to 14-6-1971 and have requested the State government to accord similar recognition.

2. Government have examined the matter in Consultation with the Kerala Public Service commission and they order that the reorganization granted to the Post-graduate Diploma in Rural Economics and Co-operation awarded by the National council for rural

Higher Education be extended for a further period of two years i.e. from 15-6-1969 to 14-6-1971. the recognition will apply only for non-academic appointments.
