ORDER

Government have in consultation with the Kerala Public Service Commission, reviewed the procedure laid down in the G.Os. cited regarding the preparation of select lists by the Departmental Promotion Committees. In supervisor of the orders in the G.Os. second and third cited the following shall be substituted for paragraph 8-A as inserted by the G.O. second cited.

"8-A. The select list prepared by the Departmental Promotion Committee in the manner referred to above shall be published by the Convener of the Committee after approval by the Government. No modification of such select list shall be made under rule 20 of the General Rules of the Kerala State and Subordinate Services Rules on the basis of re-evaluation of the confidential reports. However if any officer who has been superseded and whose name has not been included in the list makes within one month from the date of publication of the list, a written representation to the Convener of the Departmental Promotion Committee requesting a revision of the list, the Committee shall consider the representation. If it is of the view that the list already published should be revised. It may make a recommendation to that effect. The list will then be revised accordingly and published by the Convener after approval by the Government.

Wherever Government consider that there no exceptional circumstances which warrant a departure from the advice of the Departmental Promotion Committee in the

Public interest the Departmental Promotion Committee shall be given a fresh opportunity to consider the proposals of the Government to modify the select list. If on receipt of the recommendation of the Departmental Promotion Committee, Government still feel that there are exceptional circumstances which warrant a departure from the advice of the Departmental Promotion Committee in the public interest, they may take a decision accordingly. In that case it will be open to the Public Service Commission to include the matter in the Annual Report.

There notices have been issued in according with the procedure introduced by the G.O.(MS) No. 227/69/PD dated 30-7-1969 to the officers proposed to be superseded the proceedings of the concerned Departmental Promotion Committee will be considered as cancelled.
