In super session of the Government Order read above, the Government are pleased to prescribe the following qualifications and methods of appointment for the categories of Attenders performing technical duties (on Rs. 75-130) and clerical Attenders (on Rs. 85-175):-

Attenders performing Technical duties (on Rs. 75-130)	By transfer from Members of the Last Grade Service employed in the Department	IA (1) Pass in Form III (Standard VII new) or equivalent (2) Pass in the Attenders Test conducted by the Public Service Commission. OR B. (1) 5 year's regular service under Government. (2) Pass in Attender's test conducted by the Public Service Commission.

Clerical Attenders (on Rs. 85-175)	<p>(1) By transfer from among Attenders on Rs. 75-180 and Those holding other post in The same grade, in any category or service in the Departmental unit.(If no candidates Are available by item (1) above).</p> <p>(2) By transfer from persons Holding last Grade Post in the Department not coming under Item (1) above. (If candidates are not available By the above two methods)</p> <p>(3) By transfer from among Attenders on Rs. 75-130 in other Department</p>	<p>II Technical qualification or Experience required in the particular Section, Department or institution. (For all the three methods) Pass in form III or Standard VII (new) or its equivalent.</p> <p>Note:- (1) Persons holding post other Than Attenders shall be eligible for Appointment by transfer only if they have passed the Attenders Test conducted by the Public Service in addition to the other qualifications.</p> <p>(2) they must have put in at least two Years of regular service.</p> <p>By order of the Governor, G.BHASKARAN NAIR, Special Secretary.</p>
