NOTIFICATION

S R O No.76/91—In exercise of the powers conferred by Subsection(1) of section 2 of the Kerala Public Services Act,1968 (19 of 1968),read with section 3 therefore,the Government of Kerala hereby make the following rules further to amend the Kerala Service Rules,namely:-

RULES

(C. S. NO.462/90)

1.*Short title and commencement.*—These rules may be called the Kerala Service (Amendment) Rules,1990.

(2) They shall come into force at once.

2.*Amendment of the Rules:* In part 1 of the Kerala Service Rules, in sub-rule (b) of rule 60, the following Note shall be inserted, namely :-

“Note:-Ex-service men who were in armed force prior to the 7th April,1970 and who have been appointed as Last Grade Employees in the Last Grade Service in the State after the 7th April 1970 will also be eligible for the benefit of the above rule provided they continue to be in the Last Grade Service”.

Explanatory Note

(This does not form part of the notification, but is intended to indicate the general purport)

According to rule 60 (b) of Part 1, Kerala Service Rules, Last Grade Employees who were in regular service as on 7-4-1970 can continue in service upto 60 years of age as long as they continue in Last Grade Service. On the basis of the recommendation made by the Sainik Seminar, the Kerala Ex-services League has requested Government that the Ex-service who joined the Armed Force prior to 1970 and who have been appointed as Last Grade Employees in State Service after 1970 maybe allowed to continue in service upto 60 years of age like their civilian counterparts. Government has decided to extend the benefit of continuing up to 60 years of age to those Ex-servicemen who continue in the last grade service. This amendment is to achieve the above objectives.
