In the Government Orders read above, Government have prescribed General Guidelines for transfer of Government employees . In the letter read as 4th paper above, the Director of Technical Education has requested that preference in the matter of transfer and posting may be given to employees in the Technical Education Department , attending part-time Degree or part-time Diploma Course in engineering . Since the matter is also relevant to other Departments where employees need professional qualification Government consider it necessary to amend the guidelines for transfer of Government employees contained in the Government Orders read above , the following shall be incorporated as para 11(b) namely :-

II(b) Those who undergo part-time Academic Degree/Diploma/ Certificate Course will be given special consideration in the matter or transfer and posting subject to the following conditions :-

i) Such preference shall be limited to the course leading to qualifications which are obligatory or which have been prescribed as required or necessary for their promotion in the Department to which they belong and shall be limited to a period not exceeding the total prescribed duration of the course .

- This concession shall be restricted to those who seek admission to the course through proper channel/appointing authority / Government with the No Objection Certificate of the Competent authority .
- iii) They shall be retained in the transferred station even on promotion.
- iv) They should , at the beginning of each academic year, produce a certificate from the Principal/Head of the Institution where they are undergoing the part-time studies, that they continue to be on the student rolls of the Institution and that they are regular in attendance . If at any time it comes to the notice of the Department/ Government that they drop out of the course/discontinue the course or absent themselves for long periods, they will lose the preferential treatment in the matter of retention in the transferred station .
