### ORDER

According to the amendment to the Special Rules for the Kerala Last Grade Service made in G.O. (P) No.47/90/P & ARD, dated 31-10-1990, 50% of the posts coming under category 4 of the service in the Departments of Health Services, Indian systems of Medicines (including Ayurveda Colleges) Homoeo, Employees State Insurance and Medical Colleges are to be filled up by promotion of the Part Time Contingent employees of the respective Departments and the remaining 50% in the above Departments and the entire posts under category 4 in the remaining Departments, except the Departments of Animal Husbandry, Museums and Zoos, Governor's Secretariat, Departments in the Secretariat including Law, Legislature and Finance, Judicial Department, Public Service Commission, Office of the Advocate General are to be filled up by the respective applying authorities by promotion from the candidates advised by the District Collectors from the seniority list of Part Time Contingent Employees prepared on a district-wise basis. This order was stayed by the Hon. High Court in their interim order dated 11-1-1991 in C.M.P. No.735/91 in O.P. No.463/91-E, (Communicated to Heads of Departments in the letter dated 4-6-1991 read above).

Consequently the vacancies in posts coming under category 4 in Last Grade Service in various Departments remain unfilled resulting in much administrative inconveniences. In order to obviate these difficulties Government order that the vacancies in posts coming under category 4 of the Special Rules for the Kerala Last Grade Services will be temporarily filled up by promoting the Part Time Contingent Employees of the respective Departments based on the provisions in the Rules that existed prior to the amendment in the G.O., dated 31-10-1990 subject to review depending on the final decision of the Court in O.P. No.463/91.
