Sub : AIS (DCRS) Rules – treatment of Dearness Allowance as dearness pay for the purpose of death gratuity and retirement gratuity and missing the maximum limit of gratuity from 1.00 lakh to 2.50 lakhs .

I as directed to any that Central Government (Department of Pension and Pensioner's Welfare) have issued orders regarding treatment of dearness allowance as dearness pay for the purpose of death gratuity and retirement gratuity and raising the maximum limit of gratuity from Rs. 1.00 lakh to 2.50 lakhs vide their O.M.No. 7-1-95 P& PW (P) dated 14<sup>th</sup> July 1995 .

This department considered the question of extending the above orders to members of All India Service and who retire or die on or after 1st April , 1995 . It has been decided that orders now issued by Department of P & PW vide their O.M.No .7/1/95 , P& PW (P) dated 14-7-95 should also be extended in respect of All India Services . Accordingly , it has been decided that dearness allowance linked so AICPI 1201.66 as indented below shall be treated as dearness pay for reckoning emoluments for the purpose of retirement gratuity under the All India Service (DCRC) Rules , in case of members of All India Services who retire or die on or after 1st April , 1995 .

The above raise are incisive of the allowance a equivalent to 20% of basic pay already treated as dearness pay for the purpose of retirement gratuity / death gratuity with effect from 16<sup>th</sup> September 1993. in forms of this Department's letter No.25011/26/93-AIS(II) dated 16<sup>th</sup> November 1993.

3. It has been decided that the selling on the maximum amount of retirement gratuity / death gratuity may be raised from 1.00 lakh to Rs . 2.50 lakhs w.e.f. Ist April 95 .

4. In the case of person who have already retired / death on or after Ist April ,1995 the retirement gratuity / death gratuity may be recomputed one moto on the biases of these orders by the pension unnoticing authorized and arrears , if any ,paid ....

5. It has been decided that these orders any apply to the Members of All India Services who are governed by All India Service ( Depth –cum-retirement benefits ) Rules , 1958 .

6. Formal amendment of Rules 19 of AIS (DCRG) 1958 will be issued separately .
