ORDER

The one hundred and forty nine employees of the Tramway mentioned in the annexure to this order were, though permanent, non- pensionable previously under the orders of the erstwhile Cochin Government. These employees are paid from General Revenues. As a war-time measure the pay of these employees was converted in to daily wages in 1944 and this system of daily wages continued till 1952 when these non – pensionable posts were reconverted the monthly pay system as per G.P.D.Dis. 11780/51 dated 5-5-1952. They were also ordered to be treated as temporary in view of proposal to abolish the Tramways. The Government have since ordered in the G.P.F (A) 2-1081/57/AD dated 27/05/1957 to continue and renovate the Tramways. Ever since the issue of G.P.D.Dis 11780/51 dated 5-5-1952 the workers were clamoring for giving them permancy in appointment. These posts have been in existence ever since the inception of the Tramways and will have to be continued as long as the Tramway exists. The Government have therefore examined the question of making these posts permanent and pensionable. They are pleased to order that the posts of Tramway employees mentioned in the annexure to this order be made permanent and pensionable from the date of creation of the posts. All those employees who had put in three or more years of service on 5-4-1957 should be confirmed from the date on which the incumbent commenced service in the particular post. The benefit of this order will be given only to those who were in service on 5-4-1957.
