ORDER

In the G.O cited , it has been ordered that in cases where a period of temporary exemption from passing Departmental tests is allowed such period of temporary exemption will be extended by two years in the case of members belonging to Scheduled Castes and Scheduled Tribes. In the letter cited the Board of Revenue has sought the clarification of the Government whether the concession granted to Scheduled Castes and Scheduled Tribes in the G.O. cited will take effect from the date of introduction of the various Departmental Tests. The Government have reviewed the matter and are pleased to order as follows:-

The concession ordered in the case of Scheduled Castes and Scheduled Tribes allowing a further period of two years in the G.O. cited will be applicable to cases where the normal period of exemption (where such exemption was available) had not expired on or after 1-11-1956.

The G.O. cited is modified to this extent.
