Sub:- Establishment – Absorption of retrenched contingent employees and other low paid employees.

Ref:- Government letter No. 41726/SD5/68/PD. Dated 18.7.68 and 5.10.1968.

Sir,

I write to inform Government that there are no vacancies under full time contingencies as far as this Department is concerned. At present the following vacancies are available in the Last Grade Service as per the reports received from the Subordinate offices as noted against each except in Ranni division. The report regarding the detail of vacancies if any available in Ranni division has not been received so far. The Divisional Forest Officer Ranni is being reminded in the matter.

The posts of Plantation Watchers, Reserve Watchers, Watchers and Survey lascar come under the category of work Establishment Service now ordered to be converted into the regular pensionable establishment. Government in G.O. MS. 33/67/Agri. Dated 30-1-67 prescribed the qualification and physical measurements for appointments to the posts of

Watchers. Recruitment to the posts was to be made through Employment Exchange. But in G.O.MS. 336/68/Agri. Dated 4-7-68 Government have since ordered that all future appointments to the posts borne on the categories under work Establishment Service will be brought within the purview of the Public Service Commission and that the details regarding the mode of appointment, qualifications etc. will be examined and finalized separately in consultation with the Public Service Commission. Hence it may be considered whether the vacancies of Plantation Watchers, Reserve Watchers, Watchers and Survey Lascar mentioned above can be filled up from among the list of retrenched low paid employees mentioned in the Government letter cited. However I am issuing instructions to the Officers concerned to reserve the vacancies till receipt of Government orders in the matter.

In this connection I may also inform Government that at present there is a vacancy of peon on Rs.60-2-70-3-100/- in this Office. A person knowing Cycling is preferred for appointment to that post. Hence I request that a suitable person, if available among the persons mentioned may be appointed as peon to fill up the above vacancy. I may also request Government that a person willing to serve at Trivandrum may be given first preference to fill up the vacancy of peon in this office so that he may not request for a transfer after his appointment here. I request that Government may be pleased to pass early orders in the matter so that I may take steps to fill up the vacancies otherwise if they are not required for the personnel mentioned in the Government letter cited.
