ORDER

In the Government Memorandum read as first paper above Government have , inter alia, laid down a procedure for making provisional and emergency appointments through Employment Exchanges to posts with in the purview of the Public Service Commission. According to the instructions issued , provisional and emergency appointments made through the Employment Exchanges can be continued beyond three months with the concurrence of the Public Service Commission, subject to other conditions being satisfied. Instances have however, been brought to the notice of Government where appointing authorities have retrenched candidates appointed through the Employment exchanges every three months and made fresh appointments through the employment Exchanges in the arising vacancies in order to avoid reporting the vacancies to the Public Service Commission. To Prevent such irregularities, Government are pleased to issue the following further instructions:-

i) The practice now followed in the Departments of retrenching candidates appointed through Employment Exchange Every three months and making fresh appointments during the Pendency of vacancies should be discontinued. Such persons should be continued in service till a nominee of the Public Service Commission is appointed or the Commission have declined to accord concurrence to the appointment. Appointing authorities should also obtain the concurrence of the Public Service commission promptly for continuing Employment exchange hands after three months ; and

(ii) Government also direct that the above procedure will not stand in the way of throwing out temporary hands at the end of the academic year in schools and other institutions where there is authorised vacation and that while doing so, the candidates who have been so throw out should be reappointed on re-opening of the schools/institutions after the vacation provided the vacancies continue. The orders in the G.O. read as second paper above will stand modified to this extent.
