**ORDER**

In the G.O.read as first paper above Government on the advice of the Public Service Commission, have prescribed a Proforma for obtaining the concurrence of the Commission for the continuance of provisional hands beyond three months under Regulation 5 of the Kerala Public Service Commission(Consultation) regulations, 1957. In the letter read as second paper above , the Commission has requested that a new column (column11) for furnishing information as whether the question of fixing the qualification and method of appointment has been taken up with Government for the post for which they seek con currence for the continuance of the post, should also be provided in the Proforma appended to the G.O.read above and the existing columns 11 to 15 renumbered as columns 12 to 16.

2. Government have examined the case and are pleased to order that a new column be inserted as column 11 as follows in the Proforma appended to the G.O.read above.

"Column11. If qualifications or method of appointment to the post have not been fixed, whether the same have been proposed to Government; If so , furnish the reference number and date of the report and to whom it has been addressed."

The existing columns 11 to 15 will be renumbered as columns 12 to 16.

3. The G.O.read as first paper above stands modified to this extent.
