

Pattern of supervisory Ministerial posts- Fixation of strength of supervisory posts- Orders issued.

ORDER

After considering the recommendation of the Pay Commission, Government in the G.O. read as first paper above, approved a pattern for sanctioning supervisory ministerial posts in subordinate offices. Subsequently with a view to providing some further improvement in the promotional avenues of ministerial staff, Government in the G.O. read as second paper, sanctioned a revised pattern. Unlike in the case of revision of scales of pay, and ratio between higher and lower grades, the revised pattern of supervisory posts has not been given retrospective effect. The Chairman of the Joint Council of State Service Organizations has represented to Government that the pattern of ministerial supervisory posts sanctioned in the G.O dated 27th November 1969 may be given retrospective effect from 1st July 1962.

Though the orders fixing the revised pattern of supervisory staff were issued on 27th November 1969, there had been considerable delay in issuing sanctions for the creation of additional supervisory posts in each department, as per the pattern and thereby the employees lost the benefit of earlier promotions, which they could have got, had orders re-fixing the strength of supervisory posts in each office, been issued soon after 27th November 1969. The delay has occurred mainly in major departments where there are large number of ministerial posts. So the Actual benefits of additional promotional avenues to the ministerial staff sanctioned by Government accrued to the employees of various departments on different dates. In view of the above , Government are pleased to order that the strength of supervisory ministerial posts in all officers, according to the revised pattern prescribed in the G.O. read as second paper above will be normally fixed as on 27th November 1962 and national promotions given to the eligible persons and pay in the post of promotions given to the eligible persons and pay in the post of promotion fixed notionally as on that date. Actual monetary benefit on account of the promotion will, however, be admissible to them only with effect from the date on which specific orders sanctioning additional supervisory posts, on the basis of the G.O. dt. 27th November 1969 were /are issued or from the date on which the employee actually began/begun to discharge the supervisory functions, which ever is later.
