## **ORDER**

- 1. Government have decided that persons appointed provisionally by direct recruitment to posts other than teaching posts should not be allowed to continue in such posts for a period exceeding three months . In the G.O. read as 4<sup>th</sup> paper above rule 9(a) (1) of the Kerala State and Subordinate Services rules, Part II , has been amended for the above Purpose.
- 2. In supersession of the orders issued in the G.O. read as 1<sup>st</sup> paper above Government are pleased to issue the following instructions to the Heads of Departments/ Appointing authorities for strict compliance.
- i) Persons appointed on a provisional (temporary basis) through the Employment Exchanges to posts other than teaching posts should not be allowed to continue in such posts for a period exceeding three months . Persons appointed on & provisional (temporary) basis through the Employment Exchange, to teaching posts in educational institutions will however, be allowed to continue till the regular Public Service Commission recruits join duty, provided the vacancies continue and subject to the condition that the concurrence of the public Service Commission as required under regulation 5 (2) of the Kerala Public Service Commission (Consultation) regulations 1957 should be obtained by the Appointing authorities.
- ii) A person once appointed provisionally (temporarily) through the Employment Exchange and discharged from Service should not as far as possible, be reappointed through the employment exchange to the same post by the same Appointing Authority . However , in exceptional circumstances where there is no alternative but to reappoint the same person through the Employment Exchange such reappointment can be made with the prior concurrence of the Public Service Commission. These instructions will apply to teaching posts also.

iii) The orders issued in the G.O read as 2<sup>nd</sup> paper above should be strictly followed by the Appointing Authorities. Violation of orders regulating provisional appointments will be viewed seriously and disciplinary action under the Kerala Civil Services (Classification, Control and Appeal) Rules, 1960, taken against the delinquent officers.
