ORDER

Government in their order read as first paper above prescribed the new Criminal Procedure Code 1973 (Act 2 of 1974) for Part II of the Criminal Judicial Test conducted by the Kerala Public Service Commission. Consequent on this the Syllabus for other Departmental Test for which certain parts, Sections chapters of old Criminal Procedure Code have been prescribed requires change so as to substitute the corresponding parts, chapter etc. of the new Criminal Procedure Code in the place of the old one.

The syllabus for the Forest Test for Executive and controlling staff I Paper includes certain chapters of I.P. C. In revising the syllabus on the lines indicated above, Government have decided to include additionally Chapter XXIII and XXVII of the New Criminal Procedure Code in the Syllabus of Forest Test (For Executive and Controlling Staff) I Paper. The Public Service Commission has also agreed to this.

In this circumstances Government are pleased to prescribe chapters 1,5,6,7,15,16,19,20,23, 24,26,27 and 30 of the new Criminal Procedure Code as Syllabus for the Forest Test (for Executive and Controlling Staff ) Paper I in the place of the chapters of the old Criminal Procedure code.
