ORDER

In the Letter read as third paper above the Heads of Departments were directed to retain in service provisional (temporary) employees who had two years continuous service on 22-12-1973 not with standing the orders issued in the G.O. s read as first and second papers above They were also directed therein to reappoint persons coming under the above category, who had been relieved after 22-12-1973, against available vacancies , subject to the superior claims of candidate , who had already been advised by the public service Commission. In the letter read as fifth paper above it has been clarified that the years continuous provisional (temporary) service prescribed in the letter read as third p[aper above should be in one category of post. In the letter read as sixth paper above the Heads of Departments have been informed that in the case of the provisional (temporary) employees having two years continuous service on 22-12-1973 and relieved after 22-12-1973, but who were subsequently appointed as per the letter read as third paper above , the period between the dates of relief and reappointment shall be treated as eligible leave.

2. In the G.O.S read as fourth and seventh papers above, sub- rule (e) has been incorporated under rule 9 of the General. Rules, which enable Government to issue orders on any date after 16-1-1974 regularising the services of the Provisional (temporary) employees who were appointed by direct recruitment under rules (a) (i) of the General Rules and who had two years continuous service on 22-12-1973 in one category of post in the same department.

3. Government have examined the question of regularising the service of the provisional (temporary) employees who were appointed in the various departments of Government by direct recruitment under rule 9 (a) (i) of the General Rules and who had two years continuous service on 22-12-1973 in one category of post in the same department and are pleased to issue the following orders:

(i) The Services of the provisional (temporary) employees who were appointed by direct recruitment under rule 9 (a) (i) of the General Rules and who had two years continuous service on 22-12-1973 in one category of post in the same department and who are now in service, will be regularised with effect from 17-1-1974;

(ii) Candidates , if any, advised by the Public Service Commission on 17-1-1974 will be declared as senior to the provisional (temporary) employees, whose services are regularised by this order.

(iii) In the case of the provisional (temporary) employees having two years continuous service on 22-12-1973 in one category of post in the same department who had been relieved after 22-12-1973, but who were subsequently reappointed as per the latter read as third paper above, eligible leave plus leave without allowance beyond three months in relaxation of rule 88 9ii) , Part I, Kerala Service Rules , if necessary, will be granted to cover the period between the dates of their relief and reappointment:

(iv) No concession other than that applicable to persons temporarily appointed under rule (a) (i) of the General Rules will be allowed for the service rendered prior to 17-1-1974 by the provisional (temporary) employees whose services are regularised by this order.
