JAWANS KILLED/DISABLED/MISSING IN ACTION-CON
CESSIONS-ISSUE OF DEPENDENCY CERTIFICATE.**

ORDER

Government orders in G.O. Ms. 272/69/PD. dated 11-9-1969 and G.O.MS. 469/72/PD. dated 20-12-1972 contemplate the appointment of only one near relative of a Jawan killed in action/disabled in action/missing in action under the state Government Service. For this purpose near relatives has been defined as widows/wives, sons, daughters, sisters, brothers, mother, nieces and nephews of Jawan, reference being given in the order of priority above. The next of kind of the soldier shall apply to the Tahsildar concerned for the issue of a certificate in favour of the candidate for employment and a dependency certificate shall be issued by the Tahsildars in the prescribed form. In order to ensure that only one person gets the concession in respect of each service personal reported killed/missing/permanently disabled. The Tahasildar will maintain a separate register in which the names of all next of kin of the personnel killed/missing/permanently disabled with full addresses in whose favour certificate has been issued by him will be noted. The Tahsildar will retain a duplicate certificate for record. The Kerala Public Service Commission has pointed out that in one case, a Tahsildar has issued two dependency certificates in favour of two near relatives of a deceased Jawan for appointment under state Government Service and in another case a Tahsildar had issued two dependency certificates in favour of a dependent in order to enable that dependent to secure better employment.

2. In order to avoid recurrence of such irregularities the Government are pleased to order that the second sentence in the Dependency Certificate prescribed under G.O.first read above viz., " It is further certified that no certificate for employment in respect of this officer who has killed/ disabled / missing in action , has been issued " shall be substituted by " It is further certified that no certificate for employment in respect of this Officer who has Killed/ disabled/missing in action has been issued and that the details of this certificate have been entered in the relevant Register maintained in this office. The Government are also pleased to order that Tahsildars shall issue only one dependency

certificate in favour of a near relative of the Jawan. In the event of the original certificate being lost, he shall issue only a certified copy of the certificate already issued.
