#### **ORDER**

In paragraph 3 of the G.O. read as first paper above Government had ordered that candidates to the following posts will be advised by the Public Service Commission from the select list of last grade servants:-

- (i) Chainman, Town Planning Department
- (ii) Lascar, State Archives Department
- (iii) Night Watcher, Drugs Control Department
- (iv) Cooks and Barbers, Health Services Department
- (v) Lorry Cleaner and Tractor Cleaner, Agriculture Department.

In his letter read as second paper above, the Secretary, Public Service Commission has pointed out that even prior to the issue of the G.O. cited the posts of Chainman (except in the Land Revenue Department), Lascar (except in the Fisheries Department) and Watches such as Watchman, Night Watchman etc. have been within the purview of the Commission and have been filled from the list of Last Grade Servants.

Similar is the question of Lorry Cleaner and Tractor Cleaner in the Agriculture and various other Departments, i.e. they are also under the purview of the Commission.

As regards the post of Cook and Barber in the Health Service Department a separate provision in para 3 of the G.O. is found to be unnecessary in view of the general provision contained in para I (ii) of the same G.O. that all posts of Cook and Barber will reserved or promotion of part time Cooks and part-time Barbers respectively

In view of the facts the Public Service Commission is of the view that para 3 of the G.O. read above is superfluous and should be deleted. Government accept the above view and order accordingly.
