According to the G.O. first referred to as modified by the G.O. second referred to and subsequently clarified in the circular third referred to, the time limit for entertaining applications for employment assistance in the case of dependents of Government servants died in harness before 16-1-1979 but after the inception of the scheme from 21-1-1980 will be till 16-1-1980. In the case of those who died after 16-1-1979 the application for employment assistance shall be made within one year from the date of death of the Government servant. But, in such cases in the case of minor children of the deceased Government servants the applications for employment assistance shall be made within one year of their attaining majority. According to the G.O.S third and fifth referred to with effect from 16-1-1979 the maximum income limit for eligibility for appointment under the scheme was enhanced from Rs. 4200/- to Rs. 6000/- and the minimum period of service to be put in by an employees to render his dependents eligible for appointment was reduced from 10 years to 5 years.

2. It has come to the notice of the Government that in certain cases where the applicants could legitimately apply on or after 16-1-79 and become eligible in view of the enhanced income limit or reduced period of service were denied the benefit due to the fact that such applications were denied the benefit due to the fact that such application were made prior to 16-1-1979 or disposed of before the coming in to force of the orders regarding enhanced income limit and reduced period of service. Government consider that this is rather unjust and unfair. They therefore clarify that the benefit provided in G.O. (MS) 67/81/GAD dated 3-3-81 regarding enhanced income limit and in G.O. (MS) 239/81/GAD dt.25/7/81 regarding reduced period of service will be available to all all cases where the applications could legitimately be made on or after 16-1-1979 provided the applications were made before 16-1-1980 or within one year from the date of death of the Government Servant or in the case of minor children of the deceased Government Servant with in one year after attaining majority as the case may be . The mere fact that the applications were made prior to 16-1-79 and rejected earlier according to the orders then in force need not be a bar for providing employment assistance in such cases if the applicants request for reconsideration of their applications. On requisition such cases may be reconsidered ignoring the fact that the previous applications were rejected.
