## ORDER

In the G.O. read it was ordered that the Work Establishment and Contingent Employees of all departments absorbed in the regular establishment will be allowed to count their entire full-time Work Establishment and contingent Service for purpose of pension and other retirement benefits subject to the condition that the order will apply only to cases of retirements on or after 1-4-1968.

2. The Chief Engineer in his letter read as second paper above has requested Government to clarify whether the above benefits sanctioned for the employees absorbed from the Work Establishment and Contingent service the applicable to the employees who were recruited by the Public Service Commission and who have Work Establishment and Contingency Service prior to their recruitment. There cannot be a difference between Work Establishment hands recruited by the Public Service Commission to the regular Establishment. It is only reasonable that the benefits contemplated the G.O. read above are extended to the persons in the Work Establishment and Contingent Service who have been subsequently recruited by the Public Service Commission to the regular establishment.

3. After examining all the aspects of the question Government are pleased to accept the above recommendation and to clarity that the benefits contemplated in the G.O. read above also be extended to the person in the Work Establishment who have been subsequently recruited by the Public Service Commission to the regular establishment.

4. Necessary amendments to the Rules in Part III Kerala Service will be issued separately.
