### ORDER

According to the orders in the G.P. read above Dearness Allowance allowed to re-employed pensioners in respect of their re-employment pay should be reduced by the amount of Dearness Allowance, if any, drawn on pension. The Accountant General in his letter read third paper above has stated that the above procedure necessitates the re-computation of Dearness Allowance from time to time on the basis of temporary increases or adhoc increases on pension ordered by Government from time to time and that this will consequently involved the risk of over payment by over signed or otherwise. He has from further stated that Central Government pensioners are not entitled to draw temporary or adhoc increases on pension at one place and deducting it from Dearness Allowance at another place.

2. Government have examined the question in detail and pleased to order that the procedure followed by the Government of India viz. that when a pensioners is re-employed he will not be given temporary or adhoc increases in pension (which partake of the character of Dearness Allowance), will be followed by the State Government also. The re-employed pensioner will get basic pension (which partake of the character also. The re-employed pensioner will get basic pension besides re-employment pay plus Dearness Allowance on the re-employment pay.
3. The above orders will also be applicable to (i) pensioners drawing minimum pension when they re-employed (ii) pensioners re-employed in Part-time contingent posts.
4. Government are also pleased to order that the pensioners re-employed in part-time contingent posts will be exempted from the purview of Rules 119, part III, Kerala service rules regarding fixation of pay in there-employed part time contingency posts.

Necessary amendment to rule 119 of kerala service rules part III will be issued separately.
