## **ORDER**

Government of India in their Office Memorandum read as 1<sup>st</sup> paper above have granted Special Casual Leave for a maximum period of 15 days in a calendar year to the disabled ex-servicemen in civil posts in order to go to hospital in conne3ction with the replacement/treatment of their artificial limbs. In their office memorandum read as 2<sup>nd</sup> above it had been ordered that the Special Casual Leave admissible to the deserved exservice men in civil posts can be allo0wed on more than one occasion in a calendar year for appearing before the Medical Re-survey Board for reassessment of their disability or to go to Artificial Limb Centre and stay in hospital for the purposes of replacement/pretreatment of their artificial limbs.

- 2. The Secretary, State S.S. & A. Board in his letter read as 3<sup>rd</sup> paper has proposed that concessions granted by the Government of India in their Memoranda read above may be extended to the similar categories of personnel in the State Government Service also.
- 3. The Government have examined the proposal of the Secretary, State S.S, & A. Board in detail and are pleased to order that the disabled ex-servicemen employed in the State Government Service will be granted Special Casual Leave for a maximum period of 15 days at a time to go to the Artificial Limb Centre and stay in hospital for replacement/treatment of their artificial limbs. The Government also order that the Special Casual Leave admissible to the disabled Ex-servicemen in State Government Service for appearing before the Medical Re-Survey Board for re-assessment of their disability vide rule 13 in Appendix VII of the Kerala Service Rules will be granted on more than one occasion in a calendar year, if need be.
