NOTIFICATION

S.R.O.No .128/78- In exercise of the powers conferred by sub-section I of section 2 of the Kerala Public Services Act, 1968 (19 of 1968), read with sections 3 thereof, the Government of Kerala hereby make the following amendments to Kerala Service Rules, namely:-

AMENDMENTS C.S. No. 335/78

In Part II of the said rules in rule 9) A, (I0 for conditions (i) the following shall be substituted, namely:-

"(i) The connection will be given only in cases of retirement on superannuation, or not invalid, retiring or compensation pension, or with effect from 30-7-1975, in cases of compulsory

Retirement under rule 60 A of Part I of these rules, but will not be given in other cases of compulsory retirement or cases of removal or dismissed from service".

(2) In condition (ii), the following shall be added at the end namely:-

"In officers compulsorily retired under rule 60 A of Part I of these rules shall furnish the declaration within one months after such retirement".

Explanatory Note

As per rule 99 A (i) Part II, Kerala Service Rules, Travelling Allowance will be given only in cases of retirement on superannuation or invalid, retiring or compensation pension and will not be given in cases of compulsory retirement /removal from service/dismissal. The compulsory retirement mentioned in the rule refers only to compulsory retirement as a pension and will not cover the compulsory retirement under rule 60 a, Part I, Kerala Service Rules which is made in accordance with the normal provisions relating to superannuation on retirement. The above amendment is issued to clarify the position.
