S.R.O. No. 177/78-In exercise of the powers conferred by sub section (i) of section 2 of Kerala Service Rules Act, 1968 (19 of 1968), read with section 3 thereof, the Conversation of Kerala hereby makes the following amendment, to the Kerala Service Rules, namely:-

AMENDMENT

(C.S. n.339/78)

To Part II of the said rules, In rule 18, for Note I, but following Note shall be substituted, namely:-

: Note 1: Air conditioned recommendations is not recognized as a class of accommodation for the purpose of these rules except for journey on tour by officers in the scale of pay the minimum of which is not less than Rs. 1050. First Grades Officers in the scale of pay the minimum of which is less than Rs. 1,050 may however travel by air conditioned accommodation which on tour subject to the recovery of 13 paise per 10 kilometres of part thereof if it exceed 5 kilometres, from their T.A bills. This rule is applicable in the case of journeys by air-conclusioned class in Deluxe trains also.

The ammendment hereby made shall be deemed to have come in to force with effect on and from the 20^{th} January 1977.

Explanatory Note

(This is not part of the amendment, but is intended to indicate the general purport).

By G.O. (P) 26/77/Fin. dated 20-1-1977 Government have ordered that Officers in the pay scale the4 minimum of which is Rs. 1050 for above will be eligible for travel by air conditions accommodation without effecting the recovery at 15 paise per 10 K ms or part thereof as laid down in Note I below rule 18, Part II, Kerala Service Rules.

This amendment is intended to incorporate the above decision, in the Kerala Service Rules.
