ORDER

In the letter read as Ist paper above, Sri. Thampanoor Ravi, Secretary, I.N.T.U. Kerala State Committee, Trivandrum has represented to Government that he is not getting the payments of T.A Bills due to him as a member of the committee for Lorry Transport Industry from the District Treasury, Trivandrum though he belongs to Trivandrum. The sitting of the Committee is convened at various places in the State by the Regional Joint Labour Commissioner, Ernakulam. Sri Ravi had also complained that, while other members of the committee, who come from various other Districts of the State get their T.A claims encashed through the respective District Treasuries without any objection, the members of the committee who belong to the Trivandrum District alone are denied of the facility for drawing the T.A claims from District Treasury, Trivandrum.

As per Government letter read as 2<sup>nd</sup> paper instructions were issued by Government to the Regional Joint Labour Commissioner, Ernakulam to pass on the required allotment of funds for payment of T.A to the members of the above committee, who belong to the Trivandrum District along with the Bills countersigned by him to the District Treasury, Trivandrum with their specimen signature is countersigned by him.

The matter has been further examined by Government in detail with the Director of Treasuries and the Accountant General, Kerala, Trivandrum, in all its aspect and Government are pleased to issue the following orders:-

As far as the Industrial Relations Committee is concerned Joint Labour Commissioner has to be treated as the Controlling Officer having state-wise jurisdiction and to the bills countersigned by him may be cashed from any treasury convenient to the members of the committee. Since the members may be from different parts of the state,

it will not be convenient to insist that the bills should be drawn only from one particular treasury for the purpose.

To avoid drawal of fraudulent claims of non-official members of the Joint Labour Commissioner while countersigning the claims should issue a separate intimation to the concerned treasury officer along with the specimen signature of the member duly countersigned by him. The specimen signature of the countersigning officer also has to be forwarded to the Treasury in which payment is desired as provided in Ru3 25 of Kerala Treasury Code, Volume I. The countersigning officer should also ensure that the reconciliation of the expenditure is conducted with reference to the drawals in different treasuries.

As there may be different committee constituted by Government under different Departments of the State, and similar difficulties may arise in each such case. Government are pleased to direct that the procedure detailed above will be followed in all such cases, so as to enable the non-official members to encash their T.A. claims from their native Districts or from the Districts at their options.
