NOTIFICATION

S.R.O.No. 1081/83-In exercise of the powers conferred by sub-section (1) of section 2 of the Kerala Public Service Act, 1968 (19 of 1968) read with section 3 thereof, the Government of Kerala hereby make the following rules further to amend the Kerala Service Rules, namely:-

Short title and commencement – (1) These rules may be called the Kerala Service (Amendment) Rules, 1983.

(2) They shall be deemed to have come into force on the 1st day of August, 1982.

AMENDMENT OF THE RULES

In Part II of the Kerala Service Rules in Note I under Rule 59 after the words “officers deputed for training” the words “to Trivandrum, Ernakulam, Kozhikode and”, shall be inserted.

Explanatory Note

(This is not part of the Amendment but is intended to indicate its general purpot).

Rules 59, Part II Kerala Service rules provides that a daily allowance may not be drawn for more than 10 days of a halt at one place. But Heads of Departments may grant exemption from the operation of this rules as follows:

- (a) full rate for the first ten days
- (b) three-fourth rate for the next 20 days; and
- (c) half – rate thereafter.

As per Note I to Rule 59 officers deputed for training to any city outside the state can draw D.A at full rate for the first 30 days and at $\frac{3}{4}$ rate for the next 60 days in relaxation of the above Rule.

In G.O.(Ms) /37/82/P&ARD dated 29-7-1982 Government have ordered that officers deputed to undergo Training Courses at Trivandrum, Ernakulam and Kozhikode shall be eligible for D.A at full rate for the first 30 days and $\frac{3}{4}$ of the rate for the next 60 days in relaxation of the restriction imposed in Rule 59, Kerala Service Rule Part II. This amendment is intended to incorporate the above orders in Kerala Service Rules.
