SECTOR UNDERTAKINGS/AUTONOMOUS BODIES AFTER SEEKING  
VOLUNTARY RETIREMENT FROM GOVERNMENT –CLARIFICATIONS ISSUED

ORDER

In the G.O. read above, Government have ordered that all Officers who get absorbed in the I.M.G. in Government after voluntary retirement, will be allowed to draw their full salary from the institution without any education of pension, but payment of terminal benefits due from Government in such cases will be made only after the employment in the institution is over. Certain doubts have arisen regarding the terminal benefits consequent on voluntary retirement.

2. In order to make the position clear, Government are pleased to issue the following clarifications in amplification of the G.O. read above:-

- (a) All Officers of Government taking voluntary retirement for taking up appointment in a Premier Training Institution like I.M.G. and in quasi Government Institutions of the nature specified in para m(b) of the G.O. under reference, will draw full salary from the Institutions/ Organizations according to the scale of pay of such Institutions etc.
- (b) The terminal benefits, such as D.C.R.G. Commuted Value of Pension etc., due to their service in the post from which they voluntarily retired under Government will be effected only after they quit their service from the Institutions/Organizations in lumpsum without any interest.
- (c) In the case of pension there will be neither accumulation of Pension nor lumpsum payment during their service in the Institutions Organizations. Such Officers will draw the amount of pension during to them, plus the D.A. that has accrued during the period of their service in the Institutions etc., after their final quittance from Institutions. But no interest will be added to this amount.
- (d) No Special weightage of adding on to the number of years of service will be given, as they are entitled to the G.P.F. benefits admissible in the Institutions etc.

3. These orders are given effect from 1-4-1986.
