# GOVERNMENT OF KERALA Abstract

Election – intensive revision of Electoral Rolls of all Legislative Assembly Constituencies 1993 – Teachers and other Government employees appointed for enumeration work granting of off – duty Leave, ban on transfer etc. – Orders issued:-

#### **ORDER**

As per the direction of the Election Commission of India, a programme for the intensive revision of electoral rolls in all the Legislative Assembly Constituensies in the State with 1.1.1993 as the qualifying date, has been finalized and accordingly house to house enumeration will have to be carried out during the period from 24.8.1992 to 7.10.1992 For the smooth and speedy conduct of intensive revision of electoral rolls the following orders are issued:-

- i) There will be a ban on the transfer of such of those employees of Government Department and Local Bodies and teachers who are appointed either as Enumerators or Supervisors for the ensuing intensive revision of electoral rolls, with immediate effect hill 7.10.1992.
- ii) The employees of Government Department and Local Bodies and Teachers of both Departmental and Aided Schools appointed for enumeration work will be granted off duty leave for any seven days during the period from 24.8.1992 to 7.10.1992. The enumerators and Supervisors working in the hilly areas will be granted off duty leave for one more day (ie. Eight in all) during the period. The off day leave thus granted will be in addition to holidays.
- iii) Those who are appointed either as Enumerators or as Supervisors will be permitted to attend instruction classes and perform journeys to receive the enumeration pads etc. before the commencement of enumeration work, and o return the enumeration pads etc. after the completion of enumeration work. The absence of the Government employees and Teacher's for the above purpose will be treated as a duty and they will be paid T.A. for the journeys so performed as per rules by debit to the Head of Account pertaining to Election Expenditure.
- iv) The employees of Government Department as Local Bodies and Teachers appointed as Enumerators of Supervisors will be permitted to do the enumeration/Supervision as part time work and to take one hour of either in the morning or in the evening on working days during the period of house to house enumeration viz. 24.8.1992 to 7.10.1992.
